The above is subject to fulfillment of the following conditions: -

- 1. The approval is based upon the documents /data/information uploaded/submitted by the school online/offline. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye Laws.
- 2. The school will follow the RTE Act, 2009 and NCTE and the Rules made thereunder and the instructions issued thereon by the respective State /UT Govt. and the BSB from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The school should follow all the provisions contained in the Affiliation Bye Laws of Bhartiya Shiksha Board. Also, create an E-mail ID in favor of school name for further communication.
- 4. The school should go through the syllabus text books, and provision of Affiliation and Examination Bye Laws and subsequent amendment(s) therein as well as circular(s) and guideline(s) /instruction(s) issued by the Board from time to time and keep a copy thereof for reference purpose. The school is also advised to regularly visit BSB websites, i.e., www.bsb.org.in. Also, school should reate its own school website for display of all the

- information required as per BSB norms.
- 5. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to BSB. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 6. The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms.
- 7. The school shall arrange to create separate email id for the Examinations in coordination with Controller of Examination.
- 8. Service conditions pay and allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to B.S.B.
- 9. The school and its records shall be opened for inspection by an officer/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.
- 10. The school shall prescribe Bhartiya Shiksha Board Text Books in the classes and subjects in which these have been published by the Board if the board books are not published/available for the said purpose in that case the school shall prescribe NCERT books and also Teacher Training provided by the Board is mandatory. (as per BSB Affiliation Bye-laws chapter 2 clause 2.4.7).
- 11. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
- 12. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
- 13. The school will not sponsor candidates for Board's examination of any other School/Branch, which is not affiliated.
- 14. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws/Rules of the Directorate of Education in the joint names.
- 15. The school shall run one class one section as per clause mentioned in Affiliation Bye Laws. If there is requirement of increase the section, School will seek extra permission from BSB.
- 16. School is bound to produce/submit the NOC within One year from the date of issuing this letter.
- 17. At the time of granting permanent affiliation, the school must be inspected again by the board to ensure the fulfillment of conditions as mentioned by the Board. The expenditure of inspection will be borne by the school as per BSB Affiliation Bye-Laws.
