### NOTICE CLASS X, 2024-25

In 2025 Examinations, 182 students from 05 schools in 10 subjects from Haridwar, Devprayag, Chirang, Kumarikata and Bhind were registered in class X, out of them 163 candidates were appeared and according to the subjects offered by these students about 972 answer books were evaluated.

Evaluation of the answer books was done under a well-settled policy for evaluation. To ensure that the evaluation is qualitative, objective and error free, Bhartiya Shiksha Board has taken several steps. These steps include the following:

- (i) Senior Teachers with higher experience from the schools were deputed for evaluation work.
- (ii) Only 20 answer books were assigned for evaluation in 08 hrs. time to each evaluator.
- (iii) Many checks were introduced to confirm the correctness of the evaluation work.
- (iv) The quality of evaluation is cross checked at by each official involved in the evaluation process.

After maintaining the quality of the evaluation, Standard Operating Procedures were used for the preparation of results.

Although, Bhartiya Shiksha Board has taken the maximum possible steps in assessment and in the preparation of results, however, if students are still not satisfied with their evaluation/result, they are provided the facility for verification of marks, the facility to obtain the photocopy of their evaluated answer books, and re-evaluation of their answers.

Students using these facilities are requested to read the guidelines carefully before applying to avoid any inconvenience later.

Given below are the Modalities and Schedule for the All India Secondary School Examination, March 2025 for the processes of:

- (i) Verification of Marks;
- (ii) Obtaining (Scanned) Photocopy of the Evaluated Answer Book(s);
- (iii) Re-evaluation of Answer(s)

Detailed Modalities for applying for Verification of Marks, Obtaining Photocopy of the Evaluated Answer Book(s), and Re-evaluation of the answers for the candidates who have appeared for the All India Secondary School Examination, March 2025 are given below:

- 1. Requests for all the processes will be accepted only in the duly filled application form (Annexure II to IV) along with the fee as prescribed in Annexure I. No application after the scheduled date and time will be accepted.
- 2. The fee for Verification, Obtaining Photocopy of the Evaluated answer book(s) and Re-evaluation can only be deposited through Demand Draft in favour of Bhartiya Shiksha Board, Haridwar.
- 3. Incomplete/ without fee applications will be summarily rejected without any correspondence with the candidate.
- 4. Only a single application for each step per candidate will be accepted in this process. The candidate must decide in advance whether he/she has to apply for one subject or multiple subjects. Once applied, no second opportunity will be accorded.
- 5. Board will not be held responsible for any consequences due to revision of mark(s) or delay in the process, for reasons beyond control.
- 6. Decrease even by one mark shall be affected.
- 7. In cases where there is a change in marks (both increase or decrease), such candidates shall have to surrender the Marksheet/Passing Certificate which is in their possession. Thereafter, they shall be issued a new Marksheet/Passing Certificate with the revised performance.
- 8. The Fee for Verification, Obtaining Photocopy of the Evaluated answer book(s) and Re-evaluation will be non-refundable.

#### I. VERIFICATION OF MARKS:

- (a) Schedule for Verification of marks is given in Annexure-I.
- (b) Requests for Verification of marks will be accepted only in the duly filled application form (Annexure II) along with the fee as prescribed in Annexure I.
- (c) ONLY THOSE CANDIDATES WHO HAVE APPLIED FOR VERIFICATION OF MARKS WILL BE ELIGIBLE TO APPLY FOR OBTAINING PHOTOCOPY OF ANSWER BOOK(S) IN THAT/THOSE SUBJECT(S).

# II. APPLICATION FOR OBTAINING A PHOTOCOPY OF THE EVALUATED ANSWER BOOK.

- (a) Only those candidates who have applied for verification of marks in the manner as prescribed above will be eligible to apply for obtaining a photocopy of the evaluated answer book(s).
- (b) The schedule is given in Annexure I.
- (c) Requests for obtaining a photocopy of the evaluated answer book will be accepted only in the duly filled application form (Annexure III) along with the fee as prescribed in Annexure I.
- (d) Application submitted on behalf of the candidate and also the incomplete application will be summarily rejected and fees deposited shall be forfeited without any further reference.
- (e) Applicants will be provided a scanned photocopy of the Answer Book in their respective school after blocking all information relating to the identity of the Examiner/Evaluator any other official associated with the examination processes etc.
- (f) IF THE CANDIDATE DESIRES TO CHALLENGE THE MARKS AWARDED TO ANY ANSWERS, THEN HE/SHE WILL HAVE TO APPLY OFFLINE (AS PER SCHEDULE) FOR RE-EVALUATION OF ANSWERS.

#### III. RE-EVALUATION OF EVALUTED ANSWER BOOK(S)

- (a) Only those candidates who have applied for obtaining a photocopy of the evaluated answer book shall be eligible to apply for re-evaluation or challenge the marks awarded to any answer(s).
- (b) The schedule is given in **Annexure I**.
- (c) Requests for Re-evaluation will be accepted only in the duly filled application form (Annexure IV) along with the fee as prescribed in Annexure I.
- (d) Request for re-evaluation/challenges shall be accepted only for the theory portion @ Rs.100/- per question.

- (e) The applicant will have to refer to the marking scheme in the subject concerned which would be available on the official website of Bhartiya Shiksha Board i.e., www.bsb.org.in along with the question paper. Thereafter, candidates can submit an application for re-evaluation in the required question(s) with clear and proper reasoning.
- (f) Decrease of even by one mark shall be affected.
- (g) Result of the Re-evaluation will be final and no appeal or review against the re-evaluation would be entertained.

In case of all the above three activities i.e., I, II, and III, the decision of the Board on the marks awarded shall be final and binding on the candidates.

Photocopy of the Answer Book(s) under RTI-Act-2005 will be provided as per provisions of RTI Act, 2005. However, a request for verification and/or re-evaluation cannot be made under RTI Act and shall not be entertained.
