3. School conducts Students' Assessment as prescribed by the Bhartiya Shiksha Board.

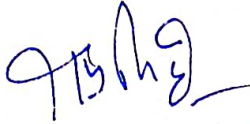
4. School follows the instructions issued by the Board regarding the school culture and environment.
