- 4. The school should go through the syllabus text books, and provision of Affiliation and Examination Bye Laws and subsequent amendment(s) therein as well as circular(s) and guideline(s) /instruction(s) issued by the Board from time to time and keep a copy thereof for reference purpose. The school is also advised to regularly visit BSB websites, i.e., www.bsb.org.in. Also, school should create its own school website for display of all the information required as per BSB norms.
- 5. The school must renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to BSB. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
