6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to BSB. 12. The rate of tuition fee and other fees charged should be commensurate with the state norms.

14. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
